- to abide by and be bound by the codes and regulations of the **Targa Florio Historic Rally** which is held under the International Sporting Code, the Sporting and Technical regulations of the FIA, the regulations of the ACI SPORT and the Supplementary Regulations.
- recognize that motor racing is a dangerous sport and to know all about the difficulties that the Rally and involves risks that may derive from participation; these facts that need to be considered and accepted by the membership. They raise from any responsibility the FIA, the ACI Sport, and the Automobile Club Palermo and all their officials, collaborators, representatives and assistants, the authority responsible for the roads used, from any liability regarding any damages to it competitor his drivers, its employees or things or products or caused to third parties or things by the competitor, his conductor and its employees. The Rallies, being rate-determining, are dangerous

As per the Italian law n. 675/96 we authorize the organizers of the event to gather and to use the above-mentioned data. In particular, by entering the rally, competitors give the Organizing Committee the authorization to use their personal data according to the Italian Law n. 196 of 30 June 2003, in order to allow the Committee to give them to the police working on the territory involved in the event. Police will then be authorized to use Entrant's data in the case in which they will be found on the route during not authorized periods and/or commit an offence to the supplementary regulations of the event.
